On the outset Chairman has welcomed the stakeholders of CCFC and other trade representatives.

At the beginning, an outreach program with Trade and Industry through power point presentation and interactive discussion on recent budget changes and their implications on Kakinada port was conducted under the Chairmanship of Commissioner. Chairman clarified several issues raised by the trade in this discussion. Custodians (M/s.KSPL and M/s.KCT) have been sensitized to ensure connectivity for cargo arrival/clearance.

Secondly Commissioner by way of a power point presentation, explained the facilities being provided to AEO status entities and urged the representatives from importers, exporters, custodians, custom house agents association, and steamer agents association to avail the AEO status. Applications in this regard were also distributed in the meeting.

### Part-A: Review of the points of the previous meetings;

#### Setting up of a Chemical Laboratory at Kakinada: 1.

Joint Commissioner informed that Assistant Commissioner Sri V.Sreenivasa Rao is nominated for this purpose and currently he is in Delhi and will pursue the matter. After his return a reminder may be sent to Chief Commissioner's office, (Action: AC CH) Vizag.

# 2 (I) Rail Over Bridge & 2 (II) Additional Land allotted to Custom House:

For allotment of additional land by the port authorities, it is advised by the that officers of Customs and stake holders and trade representatives may meet the Director of Ports and pursue the matter.

## 3. Infrastructures facilities at JJ Ghatty.

To improve infrastructure facilities such as proper roads, CCTV and Lights at JJ Ghatty for doing statutory customs work, it is advised by the Commissioner that officers of Customs and stake holders and trade representatives may meet the Director of Ports and pursue the same. (Action: AC CH &

#### New Points:

#### 1. IMPORT OF EDIBLE OIL:

Trade has requested for final assessment of Bill of Entry pertaining to Import of Edible Oil after FSSAI clearance.

After due deliberations and considering the Public Notice No.22/2016-Cus dated.18.11.2016, it was proposed that

- (a) Samples may be sent to FSSAI clearance(NBL accredited Labs such as JNTU, Kakinada)
- (b) No need of drawing of 2 set of samples.
- (c) The Bill of Entry need not be provisional. The Home consumption Bill of Entry can be given clearance (OOC) after receipt of FSSAI test report. The cargo of into Bond Bill of Entry can be permitted for discharge of edible oil from Vessel and storage in Bonded Warehouse. However, joint Bonding shall not be permitted.

The Joint Commissioner is directed to study the above proposal and send his recommendations to Hqrs., Office for further necessary action.

It is informed by the Chairman that the next CCFC meeting will be held on 1st March, 2017.
