

ORDER

In the G.O. first read above, the rate of Landing & Shipping Fees leviable at the port of Kakinada Anchorage Port in East Godavari District has been enhanced as specified in the schedule therein.

In the circumstances reported by the Difector of Ports, Government of Andhra Pradesh, Kakinada in the letter 2nd read above, Government after careful examination have decided to approve the proposal of Director of Ports to further enhance the rates of Landing & Shipping Fees leviable at Kakinada Anchorage Port in East Godavari District.

CONDITIONS

- (1.) Fractions of a ton below 500 Kgs will be charged at half rate and those of and over 500 Kgs. will be charged at full rate.
- (2.) Fire Protection and precautionary measures are to be compiled with them before and after handling their LPG under the existing LSA & PFA regulations
- (3.) The importers/ Handling Agents and Masters of the vessels are fully responsible for causalities if any in respect of Liquefied Petroleum Gas handling.
- 4) The Government shall have power to alter or revise the rates and regulations from time to time

EXEMPTIONS

- (1.) Bonafide Ship's fittings, Dunn age, provisions and stores for the use of ships.
 - 1. Ports Marine and Lighthouses Stores
 - 2. Government Servants travelling on duty
 - 3. Persons using the pier for recreation
 - 4. Fish landed from fishing boats
- (II.) Passengers bonafide personal baggage, bedding and provisions shall be allowed free but all other packages accompanying passengers shall be assessed to fee and such fee shall be paid at once.
- (III.) Goods temporarily landed from a vessel under repairs and reshipped on completion of the repairs are not liable to pay any Landing and Shipping Fees.
- (IV.) Goods temporarily landed from and re-shipped into a vessel which has entered a port owing to stress of weather, are not liable to pay any Landing and Shipping Fees.
- (V.) In case where goods shipped at one part of the Port are landed at another part, only shipping fee shall be charged.
