- 3) Shipment Royalty charges for those Bulk, Break Bulk & General cargoes covered under any commercial agreement/permissions is to be implemented as per the decision of KSPL management at the time of shipment.
- 4) Shipment Royalty charges for 'ODC cargoes & Machinery cargoes' will be applicable as per the decision of management at the time of shipment.
