Inviting applications under Regulation 4 of Customs Brokers Licensing Regulations, 2013 for conducting the written examination under Regulation to be held on 19-01-2018 - Regarding.

Attention of the Trade and all public is invited to the Regulation 4 of Customs Brokers Licensing Regulations, 2013 (CBRL, 2013).

- In terms of the Customs Brokers Licensing Regulations, 2013, applications are invited in the prescribed format of FORM-A available in the CBEC's Notification No. 65/2013 (NT) Dated 21-06-2013 for the WRITTEN EXAMINATION, as per the Notice issued by the Directorate General of Performance Management, Customs, New Delhi Central Excise Service Tax http://dgicce.nic.in/Advertisment\_CBLR.pdf) for conducting the written examination on 19.01.2018.
- As per the Notice of the Directorate General of Performance Management, 3. Customs, Central Excise & Service Tax, New Delhi, a written examination under Regulation 6 of Customs Brokers Licensing Regulations, 2013, will be held on 19.01.2018 at Vijayawada. The time and venue of the examination will be intimated later. The syllabus for written examination is as mentioned in the Regulation 6 (7) of Customs Brokers Licensing Regulations, 2013.
- The applicant shall be a Citizen of India and should fulfill the conditions stipulated in Regulation 5 of Customs Brokers Licensing Regulations, 2013. The Applicant should also ensure their eligibility before applying for written examination and completeness of the application. Any deviations noticed against the conditions of said Regulations, the applications will be summarily rejected. No deficiency memo is to be issued to the applicants regarding incomplete applications and such applications are to be summarily rejected. The applicant should go through the Customs Brokers licensing Regulations, 2013 carefully vide Notification No. 65/2013-Customs (NT) Dt. available on CBEC website www.cbec.gov.in (Refer link: http://cbec.gov.in/htdocs-cbec/customs/cs-act/formatted-htmls/cs-brokers-licensing-

regu2013). Further, the applicants may please be noted that the applications sent by post and if received after the last date shall not be entertained.

- 5. The last date of receipt of applications is 17.11.2017(Friday). All the applicants who intend to take examination may submit their applications in <u>Form -A</u> (Refer: http://cbec.gov.in/resources//htdocs-cbec/customs/cs-act/formatted-htmls/csnt65-2013-formA.pdf) from 16.10.2017 to 17.11.2017 up to 6.00 PM to the Joint Commissioner of Customs, Krishnapatnam Custom House / Kakinada Custom House and the Deputy Commissioner of Customs, ICD Marripalem Village, Guntur who in turn may forward the same to the Headquarters Office, Customs Preventive Commissionerate, Vijayawada on or before 18-11-2017 (Saturday) through special messenger along with the following documents
  - (i) Two Recent Passport size Photographs self attested (on the front side).
  - (ii) Self attested documents on Citizenship, Educational Qualifications, Financial Requirements etc. as prescribed under Regulation 5 of Customs Brokers Licensing Regulations, 2013
- 6. While submitting the application forms, concerned Joint/Deputy/ Assistant Commissioners of Customs, Krishnapatnam Port, Nellore, Kakinada Custom House, Kakinada & ICD, Marripalem, Guntur should verify and ensure that the data /particulars furnished by the applicant are true and in accordance with the **prescribed proforma i.e.** Form A under Customs Brokers Licensing Regulations, 2013.
- 7. Eligible candidates would be allotted Roll Numbers and Hall Tickets Numbers would be sent to the Custom Houses/ICD. The list shall be displayed at the respective Customs Formations of Krishnapatnam Custom House, Nellore, Kakinada Custom House, Kakinada and ICD, Marripalem, Guntur and also at the Notice Board of Commissioner's Office, Auto Nagar, Vijayawada. The applicant may collect the Hall Tickets from these Custom Houses/ICD.
- No candidate is to be allowed to appear Customs Brokers written examination on provisional basis.
- The candidate who successfully passes written examination shall be called for an oral examination. A candidate needs to pass both Written & Oral examinations to qualify for issuance of license under CBLR, 2013.
- 10. The candidates have the option to answer either in English or in Hindi. The date of written examination shall not change even if it is declared a holiday.

- 11. In case declarations made by the applicant are found to be incorrect, the application is liable to be rejected or license is liable to be cancelled.
- 12. The receipt of Applications would be start from 16.10.2017. The Applications received after the due date ie., 17.11.2017 up to 6.00 PM shall not be considered and no further correspondence in the matter will be entertained.
- 13. The concerned Joint/Deputy/Assistant Commissioners of Customs Formations are directed to bring the contents of the said Public Notice to the knowledge of all Trade Associations, Chamber of Commerce, Exporters, Importers, Customs Brokers and all the concerned.
