At the outset, the Chairman welcomed all the members, stake holders of the Trade and Industry to the Trade Facilitation meeting. As no points were sponsored by the trade associations, Chairman directed that the power point presentation on E-Sanchit, DPD, DPE, AEO schemes and public notices issued in the recent months be made.

- Shri G.V.S.S. Prasad, Technical Director, EDI (Systems) made a power point presentation on E-Sanchit, DPD, DPE, AEO schemes and Dwell Time. After completion of the power point presentation, Shri M. Ravi Shankar, Assistant Commissioner has briefed the trade regarding the recent public notices issued by the department for trade facilitation.
- The observations/directions made by the Chairman and discussions during the course of the 3. meeting at as under:

ID Cards: I.

Shri B.Rama Krishna, Manager(Finance), M/s Coromandel International Ltd, Kakinada has raised the issue regarding the issue of ID cards for AEO members. The Chairman has assured that the AEO ID Cards will be issued shortly. Also the Chairman has directed that all the agents coming to custom house and docks should possess the proper identity cards and no person should be allowed inside the Custom House/Docks without proper identity cards.

Entry Inwards: II.

In view of the recent Public Notice No.19/2019 dt.23.08.2019 wherein it has been decided to delink grant of Entry Inwards and commencement of vessel operation(unloading of cargo) to the physical act of boarding the vessel by the boarding officer, Shri B. Rama Krishna, Manager(Finance), M/s. Coromandel International Ltd, Kakinada opined that the trade, in general, are of the opinion that they can start discharging the cargo on berthing of the vessel itself. Chairman has clarified that the discharge can be commenced only after the grant of Out of Charge by the Custom Authorities. (Action: No Action)

IGST Refunds: III.

It has been observed by the Shri A. Rama Rao, Superintendent(Refunds) that the few of the IGST refunds could not be processed from the system due to errors in filing shipping bills by the exporters. However, as per Public Notice No. 26/2019 dt. 06.09.2019, rectification of errors facility has been extended upto the shipping bills filed upto 31.07.2019 and accordingly the trade has been requested by the Shri A. Rama Rao, Superintendent(Refunds) to use the facility by approaching the respective custom officers with relevant documents and get their IGST refund rectified for disposal of the same.
