The Chair welcomed the members to the meeting. The minutes of the previous meeting and the action taken in respect of points thereon was taken for consideration.

The Chair enlightened the participants about the following developments/issues:-

- a) The government has come out with DGFT's Notification no. 21/2015-20 dated 29.09.2019, prohibiting completely the export of all varieties of Onions.
- b) Import of the food stuff in baggage should be allowed for personal use and in case of the commercial imports of food stuffs through Air cargo & UB, proper FSSAI procedures are to be followed.

Queries/Greviances received:-

1. Shri Roopesh Babu, GM, ICD Kottayam raised the issue regarding improper IGST refund :-.

Shri Roopesh Babu, GM, ICD Kottayam has raised the issue that some of the exports are not getting proper IGST refund, even after filing of GSTR-1 and 3B, this is not reflecting in AC's Module.

Chair asked Shri Roopesh babu to submit the matter in writing so the matter can be properly studied and addressed.

- 2. Shri Sebestian Joseph of KSSIA raised the following issues:
 - a) The samples taken by Air Cargo Complex, CIAL, Nedumbassery, at the time of Gold Imports during May, 2018, are still not released.
 - b) The Bill of Entry No. 6284284 dated 07.05.2018 may be reassessed as landing charges @ 1% should not be levied on high value items like gold and on the same BoE, Krishi Kalyan Cess was assessed @ 10% in lieu of 3% Social Welfare Surcharge.

As the both issues pertain to Customs House, Cochin, Chair ensured to take forward the issue to the notice of Jurisdictional Commissioner for early disposal of the same.

3. Shri B N Jha, Dy. Director of Spices Board raised the issue regarding the import and export of samples for testing purpose.

Chair asked to submit the matter in writing so the matter can be properly studied and addressed.

4. Shri A A Fernandez, from CCBA raised the issue regarding the pendency of renewal of Courier License.

Chair asked to submit the details and ensure early disposal of such cases.

As no other points came up for discussion, the Chair declared the Permanent Trade Facilitation Committee meeting closed.
