<u>Point No.1:</u> The meeting commenced with the points raised during the earlier meeting. The Chairman directed the Department to reconcile the Data along with validity of the Licenses and F.D.Rs in co-ordination with the Trade and to bring the Files of operative CHAs and Steamer Agents from the Office of the Commissioner of Central Excise and Service Tax, Kakinada located at Visakhapatnam (erstwhile Visakhapatnam—II Commissionerate, Visakhapatnam).

<u>Point No.2:</u> The Trade has requested that whenever any Registration/renewal of License is made, a copy may be endorsed to the Customs Brokers Association, Kakinada so as to enable them to get the licensee registered with the Association, if he is not a Member.

<u>Point No.3:</u> The Trade has requested for conducting the examination for issue of "G" Cards by Commissioner. The Chairman informed that the examination will be conducted and a notice will be issued in this regard shortly.

<u>Point No.4:</u> The Trade has requested for waiver of bond for export cargo in view of the AP State Government Proceedings that no permission is required for movement of Rice. The Chairman has asked Deputy Commissioner to study and forward the proposals as given by the Trade with comments and Recommendation
